Teaching Innovations

- **Resource Companies** Students of political risk assessment design and conduct research projects for domestic and multinational corporations in the natural resources and energy sectors.
- Websites Students learn to create their own websites, where they present their research projects.
- *Mock Professional Conferences* Students present their research at a mock conference, in which they sit on panels, and act as discussants and panel chairs. Discussants are required to submit written comments for the paper to which they are assigned. This teaches students to give and accept peerreviews.
- *Treaty Negotiations* Students represent ministries in various countries in Eurasia. The have the goal of negotiating a treaty that all members of the former Soviet Union will sign. They first negotiate at the domestic level (State Dept. vs. Dept. of Energy, e.g.) and then at the international level. Project culminates in a written treaty.

- Oxfam Hunger Banquet Students organized an event on world hunger. We had about 250 attendees, including graduate and undergraduate students and several honored guests, notably the Provost and Vice President of Student Life. In their analysis of the event, 80% of the students said the banquet should be repeated annually or biannually.
- **Survey Design and Evaluation** Students created their own opinion poll on international affairs, analyzed the results, presented findings in class, and evaluated each team on its presentation.
- **Corresponding with Russian Students** Students engaged in an email exchange on course-relevant topics with students in St. Petersburg, Russia.
- *Team Interviewing* In small teams, students researched local human rights issues (death penalty, homelessness, and local prison conditions) and interviewed people related to the issue.
